

THE VOTING RIGHTS ACT

Can it withstand the challenges?

Speaker: Hanna Weston.

Ms. Weston. has held various positions with the local, state and national American Civil Liberties Union (ACLU) and practiced law with the Nadler & Weston law firm from 1984 - 2005.

She will relate the history of the Voting Rights Act, its role in the 2012 election, and the threats from current litigation.

Some call the Voting Rights Act the most far reaching civil rights legislation in the US. Others see it as a punitive measure or a "perpetuation of racial entitlement."

This June, the Supreme Court will rule on whether Section 5 of the Voting Rights Act is outdated and represents an overreach of federal power. Section 5 states that certain states and localities with a history of imposing unfair voting requirements, must obtain federal approval or "preclearance" before making changes to voting laws. The case was brought before the Supreme Court by Shelby County, Alabama, which claims that Section 5 is outdated because the political climate has improved and it is a burden for such states to have to seek federal review whenever they change their election laws.

Those opposing this challenge say that Section 5 is necessary to protect voting rights in the states and localities with histories of voting discrimination, especially in light of the ongoing attempts by state legislatures to pass voter ID laws and other voting restrictions.

Will this 1965 Act withstand this challenge? Is the Act in jeopardy? This law was passed by President Johnson in response to the discriminatory voting laws enforced during the turbulent civil rights battles of the 60s and is a companion to the 1964 Civil Rights Act. These challenges and their implications will be the focus of the May 16th meeting.

FEBRUARY PROGRAM PLANNING UPDATE

As a prelude to our June Annual Meeting, here's a recap of member suggestions and discussion at our February Program Planning Meetings. A similar recap will be in the Annual Meeting packet, which will be sent to you the first week in May.

The February meetings resulted in many intriguing ideas for programs and possible studies for the LWVAC 2013-2014 League year. These included unit meeting presentations, special member programs and public presentations. The manner in which we conducted our April unit meeting on gun control is also being considered as another method to engage our members in meaningful discussions.

LEAGUE STUDIES

Members suggested a new study for LWVCO regarding the rights and responsibilities of the mentally ill and the community. As this was mentioned by several Colorado Leagues, the State League has set up a task force to identify various mental health systems and programs. LWVAC members Chris Angle, Janice Green and Nancy Jackson are on the task force.

This involvement, however, has led Chris and Janice to suggest that LWVAC conduct a new study for 2013-2014 regarding mental health issues. It was also suggested by other members that LWVAC embark on a new study on the sources and uses of water in Arapahoe and Douglas County.

As you know, to adopt a new study, items must have a team of at least three members willing to conduct the research and present it to LWVAC members. It should have a general timeline and rationale for the study, a goal, and state what you plan to study. During the February meetings the water study was suggested, but no one volunteered for the study. As a mental health study has now been suggested, we are extending this invitation to those interested in doing a water study. We do, however, need something by May 28 so the management team can review the proposal before submitting it at the June 8th Annual Meeting. It does not have to be formal, but it must have a focus and a goal. LWVCO LEADERSHIP RETREAT

You are invited to attend the 22nd Annual Leadership Retreat sponsored by the LWVCO, June 21-22 at Best Western Lodge, Frisco, Colorado.

LWVUS ENVIRONMENTAL UPDATE

The LWVUS is urging members to oppose H.R. 3., the latest proposed legislation re construction of the Keystone XL pipeline.

Sponsored by Nebraska Congressman Lee Terry, the bill would allow TransCanada to begin construction of the pipeline without receiving a permit. This would bypass a decision that must be made by the U.S. Department of State after a review of the environmental impacts is completed.

According to an Environmental Protection Agency (EPA) report there are several concerns regarding risks to groundwater resources, greenhouse gas emissions, pipeline safety, alternative pipeline routes and community and environmental justice impacts, and the EPA believes these issues should be thoroughly examined before any legislation is proposed.

The Keystone XL project would construct a pipeline that starts in Alberta, Canada, goes through six US states and ends at the Texas Gulf Coast. It is estimated the pipeline would carry 800,000 barrels of oil a day and that the majority of this oil would be shipped overseas.

LWVUS UPDATE ON CAMPAIGN FINANCE

The LWVUS is currently monitoring campaign finance legislation that has been introduced in Congress and will continue to report on possible action items.

To this end the LWV Campaign Task Force would like to have copies of proposals that are circulating regarding a Constitutional Amendment on Campaign Finance/Money in Politics. Send specific proposals to Toni Larson, LWVUS Advocacy Chair and Chair of the task force to toni.larson@gmail.com. The national league needs these materials to help them evaluate the proposals in term of existing LWV positions.

LWVAC ADVOCACY

At the April 25th movie night, League members viewed a documentary about hunger in America entitled, *A Place At the Table*. During the discussion that followed, we talked with Kathy Underhill, Executive Director for *Hunger Free Colorado*.

Kathy explained the need to convince U.S legislators to reauthorize the SNAP (Supplemental Nutrition Assistance Program) and maintain its current eligibility and benefit levels. Additional items were discussed regarding the growing number of people with food insecurity and what can be done regarding this inequity. As this reauthorization will be considered this month, we pledged to talk to our senators and congressmen/women about this issue.

Thus, please look for a LWVAC Call to Action that will be be sent to all members the first week in May.
